

Network SOW Status to date 10/28/09

The Network Statement of Work (SOW) Status report presents a high level overview of GSA/Agency/Contractor progress in satisfying Agency SOW requirements.

1. Agency – (L) stands for Large Agency that is part of the Top 22 Agencies comprising 95% of the FTS2001/Crossover business volume. (O) stands for Other Agencies not included in (L);
2. Type Service – The Network service(s) included in the Statement of Work (SOW);
3. Selected Acquisition – The Network program consists of two parallel contracts – Network Universal and Network Enterprise. “U” indicates Universal. “E” Indicates Enterprise. The SOW specifies which Network contract will be used;
4. GSA 1st Scope Review – Consists of a review of the SOW requirements and an initial determination as to whether the requirements are In-Scope with the selected Network contract;
5. GSA Final In-Scope – In the event the SOW was returned to the Agency for corrections and re-submitted to GSA, GSA performs a second review of the SOW requirements for In-Scope determination;
6. Released to Vendors – The agencies In-Scope SOW is sent to each Network Universal or Enterprise (not both) contractor. Each contractor may respond to the SOW by submitting a proposal to the Agency;
7. Award Complete – The Agency has determined, based on its selection criteria, the Network contractor to fulfill the SOW requirements.
