#### Dear Potential Offeror:

(U//FOUO) The Central Intelligence Agency (CIA) is releasing the Intelligence Community (IC) Commercial Cloud Enterprise (C2E) Cloud Service Provider (CSP) <u>draft</u> Request for Proposal (RFP) on behalf of the IC as the Executive Agent of the cloud Service of Common Concern (SoCC). The Government intends to award a multiple-award, Indefinite Delivery, Indefinite Quantity (IDIQ) type contract for the C2E CSP acquisition which will provide a commercial cloud service capability to support the IC and sponsored partners. The potential period of performance of this contract is anticipated to be 15 years with a five-year base period and two five-year option periods. The contract type for task orders (TOs) will be Firm Fixed Price (FFP). The initial award will include the base IDIQ contract and Task Order 001 (Unclassified CSP Program Management Office (PMO); the evaluation for the IDIQ and Task Order 001 are combined in the draft RFP. The proposal request for Task Order 002 (Classified CSP PMO) will be released following the award of the IDIQ contract(s); draft Task Order 002 documents will be included in the Contractor Bidder's Library (CBL) by Final RFP.

(U//FOUO) The estimated award date is September 2020. Be advised that this draft RFP does not obligate the Government to award a contract.

(U//FOUO) All unclassified draft RFP documents will be posted to the unclassified IC C2E CSP Acquisition ARC page; however, any classified reference documents will be posted to the classified IC C2E CSP Acquisition ARC page. The Contractor Bidder's Library (CBL) will begin to be populated with documents on 11 February 2020. All CBL documents will be available by Final RFP release.

(U//FOUO) Potential bidders may submit questions regarding this draft RFP by using the *Draft RFP C2E CSP Questions and Comments Matrix*. This format is requested for <u>draft RFP purposes only</u>; please note that instructions for questions for final RFP are outlined in C2E CSP Section L, Instructions to Offerors. The *Draft RFP C2E CSP Questions and Comments Matrix* form is due to the C2E Contracting Officer by **24 February 2020** via unclassified email (melislm2@ucia.gov). The Government is not obligated to answer any question submitted, but reserves the right to post questions and answers to all potential bidders that may be deemed pertinent information; therefore, all questions should not include proprietary information. The Government requests all questions and comments contain a high level of specificity (i.e.: include comment/question on the proper tab of the Q&A Matrix, page number, line number, specific question/comment pertaining to the referenced section, and rationale/recommendation).
